Course Calendar Description

Several areas in knowledge-based systems are covered, including recent approaches to machine learning and data mining, inference methods, knowledge-based and fuzzy systems, heuristic search, and natural language processing.

Prerequisites

Course Format

This course will use a blended online format for delivery. Course content will be delivered primarily through pre-recorded videos. Scheduled class times may be used for supplementary materials and assessments. It is expected that students have watched the video(s) prior to the corresponding class. Live classes will be accessible through cuLearn and will be recorded.

Assignments

There will be three assignments. Each assignment will contain an implementation and an associated technical document. Implementations must be written in Python 3. Assignments may be completed in small groups of up to three students.

Quizzes

There will be three quizzes. Each quiz will each be 60 minutes in length and take place during regularly scheduled class time. Quizzes are open-book, and you may consult your notes and the textbook during quizzes. You may not consult other people during quizzes. Quizzes must be completed individually.

Project

Students will complete a project that solves a problem using techniques from artificial intelligence. The project will comprise: (1) a project proposal outlining the problem, (2) a project report detailing the work completed, and (3) a live demonstration of the work. Projects may be completed in small groups of up to three students.

Participation

Students may participate through (1) in-class discussion, (2) posting on cuLearn, or (3) attending instructor or teaching assistant office hours. To receive full participation marks, students must

participate in some capacity at least six different times throughout the course. A maximum of one contribution per week may be counted toward your participation grade. Alternative modes for participation may be added throughout the term.

Important Considerations

If you are unsure of the expectations regarding academic integrity (e.g. how to use and cite references, how much collaboration with classmates is appropriate), ask your instructor beforehand. Sharing assignment or quiz specifications or posting them online (to sites like Chegg, CourseHero, OneClass, etc.) is considered academic misconduct. You are never permitted to post, share, or upload course materials without explicit permission from your instructor. Academic integrity offences are reported to the office of the Dean of Science. You will be given a 72-hour grace period for late submission of assignments. These hours can be divided in whichever way you want across the 3 assignments. For example, you could: (1) submit one assignment 72 hours late, (2) submit each of the 3 assignments 24 hours late, or (3) divide the hours among the assignments however you want. You do not need to contact me to use the grace period. You may NOT use the grace period for your project.

Late submissions of the assignments beyond the grace period will not be accepted. Late submissions of the project will not be accepted. Technical problems do not exempt you from this requirement, so if you wait until the last minute and then have issues with your connection, you will receive a mark of zero. Consequently, you are advised to: (1) periodically upload your progress (e.g. upload your progress at least daily) and (2) attempt to submit your final submission at least one hour in advance of the due date and time.
